That I hereby agree to send the following head-and-shoulders photograph(s): One (1) 8 x 10 vertical color photo. That I hereby release title, claim and rights to photograph(s) and/or public relations materials involving me to the MTRI Pageant for use in the MTRI Pageant.

That I certify I have never been married or pregnant or given birth to a child.

Failure on my part to disclose this information to the State and National officials will automatically disqualify me from my participation in any a pageant. Scholarships or prizes of any kind, which I may receive, will be returned to the pageant. State and National pageants will be released from any and all liability resulting from my actions.
